What is the Low Carbon Fuels Coalition (LCFC)?

The LCFC is a coalition of diverse companies and organizations who all share the common goal of decarbonizing our transportation fuel supply.

The LCFC is dedicated to advocating for the support and expansion of robust Clean Fuels Standard (CFS) policies at the state and federal level.

The LCFC's market-based and technology-neutral approach means that, rather than picking winners and losers, policies are designed so that all fuels are measured by actual performance—specifically by measuring each fuel's total carbon intensity, based on its entire lifecycle of production and use.

Where Does the LCFC Work?

The LCFC engages in legislative and regulatory initiatives in states across the country and at the federal level, as well as in collaborative, international advocacy campaigns.

In individual states, the LCFC partners with local stakeholders to pass CFS legislation or expand CFS policies, depending on the needs on the ground. Whether an LCFC led and managed campaign or contributing policy and technical expertise on in-state leadership committees, the LCFC is instrumental in advancing CFS policies.

Current legislative and regulatory initiatives include the states of California, Hawaii, Illinois, Massachusetts, Michigan, Minnesota, New Jersey, New Mexico, New York, Oregon, and Washington, as well as ongoing advocacy for a national CFS. Additional states are in preliminary stages. A Clean Fuel Standard (CFS) requires fuels to become less carbon intensive over time. Carbon intensity (CI) is a measurement of a fuel's total lifecycle emissions—not just at the tailpipe—including its production, transport, and use.

A CFS sets up a credit system based on CI scores for those who refine, blend, produce, or import fuel. The CI scores are compared to an annual target that decreases over time. Fuel producers with lower carbon fuels sell credits to producers of fuels that exceed the target CI scores. The program both tracks and measures greenhouse gas reductions, and provides a market incentive to accelerate and maximize those reductions.
